1. REGRET DELAYED REPLY REF A.
2. PER REF C, THERE NO GREAT INTEREST IN DOING MORE THAN ESTABLISHING CARRERA PLANS AND WILLINGNESS ENGAGE ANTI-REGIME WORK, AND SETTING UP CORRO LINK WHICH COULD BE UTILIZED AS SW CHANNEL IN UNLIKELY EVENT CARRERA SHOWS INTEREST WORKING IN PLACE IN CUBA.
3. DURING REF A PARA 2 MANOLO RAY DISCUSSIONS WITH CARRERA IN BRUS, RAY OFFERED CARRERA 200 TO 300 DOLLARS PER MONTH UP TO ONE YEAR OR UNTIL LATTER COULD BECOME SELF SUSTAINING IN SOME JOURNALISTIC JOB KEYWAY AREA. THIS OFFER WAS FOR ACT OF DEFECTION, NOT FOR KIBARK USE AS AGENT. OBVIOUSLY, IF CARRERA DEFECTS, GETS A JOB OF INTEREST AND CAN DEMONSTRATE A PONA FIDE CHANGE OF ATTITUDE RE AGGRESSIVE ANTI-REGIME WORK, WE WOULD BE INTERESTED IN PAYING FOR HIS SERVICES. WE ARE NOT, HOWEVER, INTERESTED IN PARI, BRUS OR ANY OTHER KEYWAY STA ATTEMPTING TO PLACE HIM IN POSITION AS AN AGENT, OUTSIDE CUBA.

CUBA, ⁰²UNROMBLE 2 MAY INDICATE THAT ANTI-REGIME ELEMENTS WILLING PAY GOOD MONEY FOR INFO AND THAT HE CAN ARRANGE DEPOSITS SEVERAL HUNDRED DOLLARS PER MONTH FOR CABRERA IF LATTER CAN PROVE SELF AS INTEL PRODUCER.

5. SEE NO NEED DIRECT STA CONTACT WITH CABRERA UNLESS HE SHOWS CHANGE OF ATTITUDE AND PLANS BE IN EUROPE WEEK OR MORE PRIOR RETURN CUBA. IN SUCH CASE CABLE PRITY FOR HQS AUTHORIZATION CONTACT AND FURTHER INSTRUCTIONS.
