As the Bureau is aware, this man has been RAY's personal physician since RAY was an infant, and is now the pediatrician of RAY's children. *(X)(u)*

Since RAY may at some future time become a political figure in Cuba, it is thought well to submit the information furnished by MM 791-S at this time. *(X)(u)*

Two copies of the memorandum are furnished for the information of San Juan, since MANUEL RAY is mostly active in Puerto Rico.

This individual was an official of the Movimiento Revolucionario del Pueblo (Peoples Revolutionary Movement) (MRP), an anti-CASTRO organization, who resigned on May 27, 1961. In the past, he has reportedly made rather vague, conflicting statements regarding his position on the legality of the Cuban Communist Party (CP). Recently, he has been mostly active in Puerto Rico.

The following information was submitted by MM T-1, an eminent Cuban physician who is widely acquainted with Cuban political leaders and who has furnished reliable information in the past, on February 19, 1962: *(X)(u)*

MM T-1 stated he had known RAY RIVERO since the latter was born, and had observed from time to time his leanings from one side to the other and rather unusual and contradictory political statements. *(X)(u)*

MM T-1 stated he learned in January of 1962, that RAY was holding conferences in San Juan, Puerto Rico. He ascertained that RAY and several of his friends, who are engineers and architects, were holding a series of conferences on democracy. RAY became involved at one of his conferences in a discussion in which he stated he was a Socialist. When he was asked for clarification by some of those present, he fell into the evasive manner of answering which has been characteristic of the political life and activity of RAY. *(X)(u)*
