For information of all offices conducting interviews with persons who were contacted by JOE MEROLA and/or CHESTER GRAY from New York City during September, 1958, it should be noted that CHESTER GRAY is a name used by CHESTER ZOCHOWSKI, Chicago and Miami internationally known jewel thief who has numerous connections in Cuba. JOSEPH RAYMOND MEROLA is also an internationally known thief but not so well known as ZOCHOWSKI.

It is suggested all offices conduct credit and criminal checks on persons called by the above men before they are interviewed.

Chicago will interview CG 6132-C, who is well acquainted with both MEROLA and ZOCHOWSKI, for information which might tie them to this case as subjects and conspirators, before conducting any further investigation.
